Chief of Police Message

Dear Mayor Dehen and City Council Members:

It is my pleasure to present to you the 2021 North Mankato Police Department Annual report.

Although we may be getting back to a sense of normalcy after two years of living with COVID19, we are still cognizant of the impacts and challenges this pandemic has presented. When the pandemic was surging due to the omicron variant, the police department faced significant staff shortages due to illness or quarantines for exposure. As an agency with only 15 officers, it doesn't take many officers to be absent to result in significant coverage impacts, but through it all our officers worked extra shifts, worked longer hours, and continued to be there for our community.

We are now in a time where we can engage in more in-person activities, training, community events, and community outreach. This last year saw the return of events like Fun Days, Blues on Belgrade, Concert on the Prairie, and so on, and it is refreshing for us to have contact with our community members again.

In addition to regularly assigned duties, our staff continues to support other community events such as Shop with a Hero, reserve park patrols, the Polar Plunge, Casting with a Cop, Picnic with a Cop, Cone with a Cop, and many other community events. I am confident that as you review the activities highlighted on pages 16-22 you will see our commitment to community engagement and partnership.

North Mankato Police staff have a long and proud history of going above and beyond for the community. Some of these actions resulted in awards for bravery and lifesaving this last year. Officer Hendrickson was awarded the Medal of Valor for his role in an active shooter situation that took place on the MN River in 2020. Lt Morgan, and Officers Vitzthum and Kruger were awarded letters of commendation for their life saving efforts at a sudden cardiac arrest medical in which the patient not only survived but was present to help present the awards to the officers.

We saw some change in agency staffing this last year due to a retirement. Officer Brad Schultz retired in December after serving in law enforcement for 31 years. Officer Schultz's dedication to public service, professionalism, and his kindhearted nature will be truly missed. We wish him well in his retirement.

Calls for police reform and negativity towards police in the past two years had an impact on police departments nationally and in Minnesota. We remain committed to making sure our actions reflect best practices and transparency in our operations to maintain the high level of trust our community has in us. As such, this year's annual report is the first year in which we published our use of force and arrest/citation data broken down into community demographic.

We are profoundly grateful for the community's support and look forward to serving the community in 2022 and beyond.





Training

Officers who serve the citizens of North Mankato receive a wide variety of training. Some of the training is mandated by the State of Minnesota. These areas include: Firearms, Response to Resistance, Emergency Driving, Crisis Intervention/Mental Illness, Conflict Management/Mediation and Recognizing Diversity and Cultural Differences. The department utilizes an online training service through the League of Minnesota Cities to provide training that can be completed at any time and requires no travel. The training includes any new court decisions and how they affect law enforcement, Occupational Safety and Health Administration (OSHA) classes and critical knowledge for officers. The average officer devotes over 50 hours a year to training.

Investigations

The investigations unit consists of supervisor Lieutenant Nicole Adams and Investigator Brian Gangelhoff. This unit is responsible for the coordination of all types of criminal investigations from felony to misdemeanor level crimes. This team is trained in death scene investigations, evidence collection/maintenance, and conducting interviews. The investigations division collaborates with other agencies for investigation and prevention purposes.

In addition to investigating criminal cases, the unit oversees local predatory offenders, and coordinates local compliance checks. Currently there are 26 registered offenders in the City of North Mankato.

The investigation unit also maintains a secure drop box which allows citizens to anonymously dispose of waste pharmaceuticals and narcotics free of charge. In 2021, 718 pounds of pharmaceutical waste including prescription drugs, over-the-counter medicines, narcotics, vitamins, supplements, and ointments were collected. Since inception 2,505.5 pounds of pharmaceutical waste have been properly disposed at a licensed incinerator within the State of Minnesota.

Administrative Support Services

Lieutenant Nicole Adams oversees the administrative support unit for the North Mankato Police Department. This unit is staffed with one full-time Senior Police Secretary and one-part time Police Secretary. The secretaries are responsible for administrative support including but not limited to record and citation processing, non-emergency dispatching, firearm related background checks, receptionist duties and providing excellent customer service.

The Senior Police Secretary also serves as the Bureau of Criminal Apprehension Terminal Agency Coordinator, National Incident-Based Reporting Agency Coordinator, and Data Practices Designee for the department focusing on compliance, processing requests for information, and compiling departmental statistics.

In 2021, administrative support services processed 7,841 records, conducted 129 firearm permit backgrounds, processed 245 citations, assembled 138 incidents for prosecution, resolved 56 suspense files and fulfilled 787 requests for information along with several other administrative functions.

Patrol Division

The patrol division is overseen by Lieutenant Dan Forster and Lieutenant Shawn Morgan and consists of 10 patrol officers. Our patrol officers represent the police department with focus on service with compassion, integrity, and professionalism. They respond to all calls for service including but not limited to high-risk situations, active criminal matters, disturbance calls, accidents, missing children, medicals, animal complaints and suspicious circumstances. Patrol officers also enforce traffic laws, conduct school patrols, and attend community events.

The Patrol division works 12 hour shifts and provides a minimum coverage of two officers per shift to serve the community around the clock - 24 hours a day, 7 days a week.

NEW HIRE



Officer Dillon Brashear was hired in October 2021 to fill a vacant patrol position from the previous year. Officer Brashear previously worked for the Blue Earth County Jail, a part-time Police Officer for the City of Eagle Lake and most recently worked as a full-time Police Officer for the City of Northfield. Officer Brashear grew up in the area and is excited to be working closer to home. He looks forward to getting to know the community.

RETIREMENT

Officer Brad Schultz retired on December 31, 2021, after 31 years in law enforcement. Brad Schultz joined the North Mankato Police Department on March 19th, 2012. In 2015, Officer Schultz became supervisor of the Police Reserve Unit. His patience, dependability, and mentoring ability will be missed. We wish Brad all the best in his life after law enforcement.

Police Reserves



The reserve unit is headed by Reserve Chief David Krueger and supervised by Officer Brad Schultz, Officer Audrey Kruger and Officer Matt Larson.

The North Mankato Police Reserve Unit is a dedicated team of volunteers serving the community by assisting with local events and summer park patrols. Throughout the unit's history the reserves have donated hundreds of thousands of hours to the citizens of the City of North Mankato.

The reserve unit receives ongoing monthly training in various aspects such as basic first aid, Cardiopulmonary Resuscitation (CPR), Automated External Defibrillator (AED) use, mental health crisis response, flood preparations, flood levee patrol, traffic management, skywarn, search, rescue and scenario-based training.

Tactical Response Team (TRT)

The North Mankato Police Department currently has two members on the Tactical Response Team: Lieutenant Forster, and Officer Froehlich. Lieutenant Forster currently serves as the Commander for the Tactical Response Team.

In 2021, retired TRT member Officer Hendrickson was presented the Medal of Valor for his role in a 2020 critical incident.

This team is committed to excellence and keeping our communities safe.

Crime Statistics

Crime data is reported to the Minnesota Bureau of Criminal Apprehension (BCA) and the Federal Bureau of Investigation (FBI). The FBI required agencies to transition to the National Incident Based Reporting System (NIBRS) by 2021. This transition improved the quality of crime data collected and captures details on separate criminal offenses within the same incident.

NIBRS requires differing levels of detail in reporting Group A and Group B offenses. Group A offenses are the more serious crimes and include all incidents reported to Law Enforcement. Group B crimes tend to be minor in nature and require an arrestee segment for submission. The data in these reports continues to change as open investigations are completed and charges filed with the Minnesota Court System. The reports below are current as of 1/31/2022.


Use of Force


The North Mankato Police Department is committed to being transparent in all aspects of our police service, including the incidents in which our officers must use force in the performance on their duties. Our officers strive to control and deescalate situations, but unfortunately not everyone we encounter is cooperative, and sometimes we must use force to defend ourselves/others or take people into custody.

In 2021, the department had 7,841 calls for service with 25 incidents presenting level of resistance requiring use of force reports: these incidents represent 0.319% of the department calls for service.

A single incident may contain more than one response to resistance report if multiple officers responded or multiple subjects were involved. Of the 25 incidents resulting in use of force; there were 26 subjects and 32 reports completed.

Calls for service


Each call for service is assigned a call title. Calls may include multiple criminal offenses and non-criminal activities; however, they can only be assigned one call title within the records management system.

Noteworthy Incidents

A male punched a female and attempted to hit her with a hammer during an assault. Another male was injured when he attempted to grab the hammer from the suspect. The suspect was arrested and criminal charges for 2nd Degree Assault were filed under Court File# 52-CR-21-19.

An employee of a local business reported she was being harassed by a male customer. The employee stated the male asked if he could take pictures of her and asked what time her shift ended. The male took a BB gun out of his backpack and exited the business. While outside, he shot a garbage can with the BB gun. NMPD responded and located the male who was arrested. The BB gun was recovered, and criminal charges were filed under Court File# 52-CR-21-107.

A male was reported throwing rocks at vehicles and filming as they drove by. Officers responded to the area and located the male who was having a mental health crisis. The male was holding a flashlight in each hand and was threatening to commit an assault. Officers were able to de-escalate the situation and talk him down. The male was taken into protective custody and transported to MCHS-Mankato for an evaluation and treatment.

Officers responded to a vehicle rollover in the parking lot of the Norwood Inn. Officers located a vehicle on its roof and the driver still inside and unresponsive. Officers were able to remove the male driver and found he was unresponsive and not breathing. CPR was initiated until Mayo Clinic Ambulance arrived. The male was pronounced deceased at the scene. MN State Patrol investigated.

Officers responded to a disturbance involving a suspect who threw a brick, one holding a sledgehammer and another suspect who has a rifle. The suspects were quickly located and taken into custody. A rifle was located, and it was determined to be an air rifle. Two suspects were arrested, and criminal charges filed under Court File# 52-CR-21-123 and Court File# 52-CR-21-124.

Officers responded to a group home for a client who was upset. The client damage property in the residence and tried to stab herself in her arm and neck with a fork. The officer observed marks on her neck and wrist which were consistent with her story. The female was taken to MCHS-Mankato for further treatment.

Officers responded to a residence for a male who had overdosed on Methamphetamine. On their arrival, the officers were met by the patient who was out of control and violent which resulted in a physical confrontation. The officers were able to subdue and control the male. The male was transported to MCHS-Mankato for treatment. Due to short staffing, Mankato DPS responded to assist NMPD during this incident.

A juvenile reported their father choked them and beat them with a belt because the father felt they had disrespected him. The father then kicked them out of the house. The juvenile had injuries which were consistent with their story. The father was arrested for Domestic Assault with Strangulation. Criminal charges were filed under Court File# 52-CR-21-192.

A resident of a local group home became upset when she could not have a peanut butter and jelly sandwich for supper. The client purposely punched a glass window which broke and cut her arm. The client also intentionally swallowed glass to harm herself. Officers were able to calm the resident and apply bandages to her lacerations. The resident was transported to MCHS-Mankato for further treatment.

A resident of a local group home was able to enter a running vehicle parked in the driveway. The resident locked the vehicle doors and would not comply with staff to unlock the doors. The resident then moved into the driver seat. Staff was concerned the resident would attempt to drive off with the vehicle. A NMPD Officer and Nicollet Co Sheriff Deputy arrived and were able to remove the individual from the vehicle. The client was released to staff.

Officers responded to a bicycle accident on the North Mankato Bike Trail and Hwy 14. A juvenile lost control and crashed his bicycle resulting in a possible fracture to his arm, wrist, and a large amount of road rash to his body. The juvenile was transported via ambulance to MCHS for further treatment.

Officers responded to the Spring Lake Park Pool for a report of a juvenile who drowned, and CPR was in progress. Officers assisted with lifesaving efforts. After the patient was transported, officers provided supportive care to the pool employees and conducted a preliminary investigation into the incident.

A witness reported multiple people destroying a vehicle parked in the parking lot of a local apartment building. An officer quickly located the suspect vehicle after it left the area and detained three of the occupants. The witness provided cell phone video of the three suspects damaging the vehicle. One of the suspects used a jack handle to break out the vehicle windshield. The vehicle sustained several thousand dollars' worth of damage. The three suspects were arrested, and criminal charges were filed under Court File# 52-CR-21-224, 52-CR-21-225, and 52-CR-21-226.

Officers responded to a medical involving a person with difficulty breathing. On their arrival they observed bystanders were in the process of performing CPR on the patient. Officers quickly assessed the patient and found she had a pulse but was unresponsive. The officers also believed the patient may have used narcotics prior to becoming unresponsive. The officers administered Narcan to the patient, who regained consciousness shortly afterward. The patient was transported to the hospital for further treatment.

A resident of a local group home called 911 stating the staff member had left them alone. On arrival police discovered the client alone and later determined the staff member decided to quit and just left. The client was not to be left alone for any reason. Officers were able to find safe placement for the client. Criminal charges are pending against the staff member.

A homeowner heard noise coming from the downstairs area and went to investigate. He discovered three juvenile males were burglarizing the home. All the suspects were eventually identified, and juvenile petitions were filed with the court. Officers responded to a report of a house fire on Wheeler Ave. On their arrival, officers observed flames coming from the roof. Officers verified the residence was evacuated and assisted in retrieving pets from the home.

An employee arriving to work at a local business heard a noise coming from the basement area. Upon investigating, the employee observed a male who had broken out the overhead garage door window and was reaching inside to unlatch the garage door. The employee immediately exited the building and called 911. The suspect was located, and criminal charges were filed under Court File# 52-CR-21-403. It was later determined that the suspect had prior charges for stabbing an individual in the neck with a screwdriver.

An 11-year-old child was walking in the slough area of Spring Lake Park when she became stuck in the mud up to her waist. A good Samaritan attempted to assist her, but he also became stuck in the mud. Officers and firefighters responded to the scene. The firefighters had to dig around the girl to remove her from the mud.

A person went to speak to a friend at a local apartment building. As the person went to ring the doorbell a male opened the door and pointed a shotgun at the person. The person was able to escape the area with their toddler unharmed. Officers and other law enforcement agencies arrived and were able to arrest the male suspect without incident. The male admitted to pointing a BB gun at the person when he opened the door. Criminal charges were filed under Court File# 52-CR-21-447.

Officers were advised of a resident in a group home who was out of control and breaking windows. When officers arrived in the area, they located the resident who was walking down the street and carrying a pair of scissors. The resident initially refused to drop the scissors when ordered. Officers were eventually able to speak to the group home resident and take him into custody without further incident. Staff stated the resident pulled the TV off the wall and used bricks and rocks to break out the windows and damage a vehicle.



Public Relations & Education

Connecting with the community continues to be a focus for the North Mankato Police Department. In 2021, the Police Department participated in 94 public relation and education events and documented 187 school patrols.
