Port Authority

Members of the Port Authority will be on hand to discuss revitalization efforts in the downtown and related issues.

Proposed Amendment to Charitable Gambling Ordinance

Mayor Dehen has been approached by the Lake Washington Improvement Association requesting a modification of our Charitable Gambling Ordinance that would allow them to conduct charitable gambling at Hott Shotts Bar. As the Lake Washington Improvement Association does not meet any of the current criteria, they are requesting that you consider an extension of the allowable radius to include points within two miles of the limits of Independent School District 77.

Swim Facility

We have included the operation of the swim facility in the approved 2011 General Fund Expenditures Budget. With approximately two months to go before the opening of the swim season, we will need to decide now if we intend to open the pool as scheduled. As we have no definitive information at this time from the Legislature, the Council will need to determine how to proceed on the swim facility. The Finance Director has calculated the estimated net savings in the General Fund if we do not open the swim facility in 2011.

SUBJECT: Swim Facility Budget

I have completed an analysis of the savings recognized if the swim facility is not opened in 2011.

Total 2011 Budgeted Revenue \$36,800.00

Total 2011 Budgeted Expenditure \$99,710.00

Amount Subsidized from Levy \$62,910.00

Fixed Expenditures (Insurance and Part of Utilities) (\$5,535.00)

Net Savings <u>\$57,375.00</u>

Aging to the Max in the Greater Mankato Area

VINE Faith in Action is actively raising funds to obtain and re-purpose the 60,000 square foot Nichols Building. Located within the central core of Mankato, this landmark building would house the senior programming of the Summit Center and consolidate the offices and programs of our organization. Blue Earth County has agreed to sell the Nichols Building to VINE for \$1.00, provided we can generate the resources needed to renovate this former

MSU Lower Campus classroom building. Funds to rehabilitate the building envelope, estimated at \$1.7 million, are needed by this fall. Total project cost, including floor build-outs, is \$4.3 million.

VINE plans to create a "one-stop shop" for aging adults, a place to improve physical health, socialize with peers, volunteer to help others and access needed services. This much-needed new community resource will include a state-of-the-art adult center, a café, community meeting rooms, a fitness center with a warm water exercise pool, an adult respite center, a large chore garage and office space for VINE's administrative and program staff and volunteers.

VINE is committed to helping older adults remain healthy and living in their own homes for as long as it is safe and reasonable to do so. This past year, 566 trained adult volunteers assisted over 3,500 community members with transportation, home chores, respite care, friendly visits and a multitude of other tasks that helped neighbors through the challenges of life. Since VINE assumed management of the Summit Center in 2006, weekly participation has grown from 50 to 485 people per week. The organization is rich in human resources; however, additional space for programming and parking is critical for continued growth.
