

Training

The purpose of this report is to provide a general idea of the types of training and hours completed by members of the North Mankato Police Department.

MN POST Board requires officers to complete a minimum of 48 hours of continuing education within the three-year licensing period to maintain and renew their licensing. Active officers are mandated to train annually in use of force and once every five years in emergency vehicle operations/pursuit driving.

In addition, officers of the North Mankato Police Department are required to complete annual firearms, Taser, defensive tactics training, and biennial 1st responder medical training. It is the officer's discretion which law enforcement related courses they complete to satisfy the remainder of the required forty-eight hours.

Beginning in July of 2018, a new state funded mandated requiring officers to attend an additional 16 hrs. of training in crisis intervention and mental illness crises; conflict management and mediation; and recognizing and valuing community diversity and cultural differences to include implicit bias went into effect. We continue to seek out training that fits the criteria of the new mandate.

In 2018, the North Mankato Police Department completed approximately 1286 hours of online and classroom training including our biennial 1st responder training.

The three officers assigned to the River Valley Tactical Team completed approximately an additional 270 combined hours of specialized training as part of their monthly team training. Training includes but is not limited to firearms, barricaded suspects/subjects and negotiation, high risk warrants, hostage negotiation and rescue, entry training, crowd control, active threats, VIP security, chemical/impact munitions, and distraction devices.

Of interest:

Numerous officers attended the annual MSCIC Conference. MSCIC has been bringing low cost, high quality training to area departments. This year's keynote speakers were the ATF agents who investigated and captured Pablo Escobar.

Multiple officers attended training on Elder Abuse. Something which tends to be underreported and presents challenges to investigate.

Investigator Gangelhoff became an instructor on the expandable baton and OC spray. He now provides training for our department on the expandable baton, oleoresin capsicum spray, and their proper uses.

Officer Hendrickson attended close quarter pistol and rifle retention as well as "reality-based scenario" train the trainer course. Both of these courses allow our department to do more internal reality-based training including "force-on-force" type training.

Officer Mueller became a "Lock-Up" instructor. This is the defensive tactics course that all officers on our department participate in each year. He will now assist Officer Gangelhoff with our annual defensive tactics training.

Officer Tordsen became a qualified Phlebotomist. He is now able to complete evidentiary blood draws with a warrant for our department.

Officer Kral completed both handgun and rifle armor's and instructor's course. He will be assisting Officer Hendrickson on the range to ensure our firearms program functions smoothly, safely, and our officers are trained to a high standard.

Officers VonBerge completed a 30-hr. leadership course hosted by MN Chiefs of Police at Camp Ripley.

Officer VonBerge completed the Taser Instructor course and will be taking over the Taser program for the department.

This year, many officers throughout the department took on instructor roles and new training responsibilities. This is a great way to keep the training fresh and bring new ideas.

As we move forward, there will be continued training emphasis on responding to persons in crisis, the mentally ill, and impaired. Health and wellness programs are being adopted by more agencies as part of officer survival. Finally, technology is becoming increasingly important from the delivery of on-demand learning modules to <u>use-of-force simulation</u> that approaches virtual reality.

Patrol Division

The patrol division is often the first and only contact many citizens have with our police department. Patrol officers respond to a variety of emergency and non-emergency calls for service including vehicle crashes, medical emergencies, burglaries, traffic enforcement and crimes in progress.

The patrol division is overseen by Lieutenant Dan Forster and Lieutenant Shawn Morgan and consists of 10 patrol officers. The North Mankato Patrol Division operates 24 hours a day, 7 days a week.

Investigation Unit

The investigations unit consists of supervisor Lieutenant Adams and Investigator Gangelhoff. This unit is responsible for the coordination of all types of criminal investigations from misdemeanor to felony level crimes. This team is trained in death scene investigations, evidence collection, interviewing and interrogations.

In addition, the investigation unit completes registration and maintains files for all predatory offenders that reside in the city limits of North Mankato. Currently there are 21 registered offenders in the City of North Mankato.

Administrative Support

Lieutenant Adams oversees the administrative police secretaries that provide support to the Police Department.

The North Mankato Police Department has one full-time police secretary and one part-time police secretary. These secretaries are responsible for administrative support including but not limited to customer service, records processing and non-emergency dispatching. In addition, the full-time secretary is responsible for crime analysis and the management, retention, and dissemination of records.

POLICE/PARAMEDIC PROGRAM

In 2018, Officer Mikeal Tordsen established a police/paramedic program. Combining his talents as a paramedic with Mayo Clinic Ambulance and police officer with North Mankato Police Department; Tordsen was able to initiate a unique partnership between his employers. Now, while on duty as a patrol officer, Tordsen is sanctioned to serve as a paramedic and carries extra medical equipment in his squad car to provide advanced medical care.

MINNESOTA RIVER VALLEY TACTICAL RESPONSE TEAM

Lieutenant Forster, Lieutenant Morgan, and Officer Hendrickson are members of the Minnesota River Valley Tactical Response Team. This team responds to high-risk law enforcement situations in Le Sueur, Blue Earth and Nicollet Counties.

Police Reserves

The North Mankato Police Department Reserves are a group of dedicated adult volunteers who provide critical support functions to the agency and community. Reserve officers are tasked with performing community service tasks and help with non-criminal duties including patrolling neighborhoods, parks, traffic control and security at city events, and riding with the officers. In addition, reserves play a vital role in helping with the annual Fun Days Festival, Bells on Belgrade, Blues on Belgrade, Kiwanis Lights, ABATE motorcycle parade, numerous marathons, and many other events.

As illustration of the time and effort the reserve officers provide our community, in 2018 the reserves volunteered 1322 hours at 37 different community events, attended over 172 hours of training, and completed 129 administrative hours.

The North Mankato Police Department is proud to have such a dedicated and hard-working group of people who are willing to volunteer their time to help better the community.


CALLS FOR SERVICE

COMMUNITY OUTREACH



Connecting with the community is a high priority for the North Mankato Patrol Officers. Through community outreach we become positive role models for the community. Some of the ways that this is done is through neighborhood supports activities such as but not limited to medication collection, community events, and public education.

In partnership with Nicollet County and Excel Energy, the North Mankato Police Department implemented a Medication Collection Program in 2015. A secure drop box allows citizens to anonymously dispose of waste pharmaceuticals and narcotics free of charge. All items collected are disposed at a licensed incinerator within the State of Minnesota. Since inception, 1,186 pounds of pharmaceutical waste including prescription drugs, over-the-counter medicines, narcotics, vitamins, supplements and ointments have been collected and properly disposed. The collection drop box is available in the North Mankato Police Department lobby during normal business hours. In 2018, 390 pounds of waste were collected.

In 2018, the department joined with Neutral Groundz to hold Coffee with a Cop and Culver's to hold Cone with a Cop events. The department also teamed up with the North Mankato Taylor Library for Storytime with a Cop.
